Venue is proper in Calhoun County, Texas, pursuant to Sec. 15.002 and 15.005, Texas Civil Practice and Remedies Code, because a substantial part of the events or omissions giving rise to the claim occurred there. Plaintiffs, while living and/or working in Calhoun County, Texas, were exposed to asbestos, which caused their injury and disease. Plaintiffs anticipate that discovery in this case will be governed by Level 3, Tex.R.Civ.P. 190.4.

Plaintiffs, through their employment, were exposed to asbestos and asbestos-containing products mined, manufactured or distributed by the defendants herein named. Plaintiffs allege that the products mined, manufactured or distributed by the defendants when used in the intended manner emit harmful asbestos fibers into the air which were inhaled by Plaintiffs causing damage and harm to their bodies. Plaintiffs allege that at all times material hereto, all of the defendants were aware of the fact that Plaintiffs and others similarly situated were regularly being exposed to the hazards of the asbestos disease. Although each of the defendants knew of the dangers and hazards and even
