**WHEREAS**, on this the 18th day of September, 2020, the Commissioners' Court of Calhoun County, Texas convened in regular session with the following members present:

David Hall - Commissioner, Precinct #1  
Vern Lyssy - Commissioner, Precinct #2  
Clyde Syma - Commissioner, Precinct #3  
Gary Reese - Commissioner, Precinct #4

**AND WHEREAS**, the matter brought before the Court was the adoption of the 2021 budget as required by SB 2 of the 86<sup>th</sup> Texas Legislative Session;

**AND WHEREAS**, after notice, the following motion was offered by Vern Lyssy and seconded by David Hall: "I Move to adopt the 2021 Budget for Calhoun County as presented."

The tax rate for the year 2019 was 0.5572.

The calculated tax rates for the Year 2020 are:

No New Revenue Rate	<u>.5483</u>
NNR M & O Rate	<u>.6284</u>
Voter Approval Rate	<u>.6092</u>
Debt Service	<u>.0337</u>

The total county debt obligation is \$3,255,000.

**THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$1,269,146 WHICH IS A 6.717% INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$683,583.**


**THEREUPON**, the vote being taken, the following vote for the adoption of the budget for Calhoun County for Fiscal and Calendar Year 2021 was as follows:


